Visit <a href="http://www.cccbsi.org/cb21-information">http://www.cccbsi.org/cb21-information</a> for more information and to see the rubrics.</li> <li>• There is a gap between adult education and the community college courses (between CB 21 C and CB 21 D). We need to address this gap.</li> <li>• Common Assessment Initiative is a community college placement test being developed: <a href="https://www.cccassess.org/">https://www.cccassess.org/</a></li> <li>• Report specifies attainment of a “living wage” not minimum wage. You can view a living wage calculator here: <a href="http://livingwage.mit.edu/">http://livingwage.mit.edu/</a></li> </ul> <p>3. Review activities plan</p> <p>Conference – October 25: the opening session will go over new information from the state and CASAS reports. The breakout sessions will be work groups where attendees can share and develop new formative assessments. Val suggested that CTE discuss the workplace CASAS and the CASAS soft skills certification. It would be beneficial to bring out a CASAS representative.</p> <p>Counselors &amp; Support Staff Fair/Partner Breakfast – February 2018: We want to promote adult education to partners who can bring us students and improve the reputation of adult education (high school counselors, AJCCs, library literacy programs, elected officials, social services, Cal Learn, Cal Works, mental health, probation officers, vet representatives, etc.) Bring a list of these partners to next meeting. Likely, high school counselors will not be able to attend. As Adult School counselors it is important that you visit the high school counselors a few times a year to remind them of the programs you offer at your site.</p> <p>4. Review Best Practices</p> <p>Members present do not have an up-to-date counseling handbook at their schools. The best practices document is a good first step to create this handbook.
